# Relevant facts emerged during hearing.

Previous Hearings:

First : 14.11.2024

Order of the first hearing: "The commission observes that FAA, the DC, Koloriang, Kurung Kumey District has not heard the appeal filed to him which

violates the Arunachal Pradesh Right to information (Appeal Procedure) Rules, 2005. The PIO shall furnish information to the appellant within one month from the date of issue of this order i.e. on or before 14.12.2024 under intimation to this commission. The appellant shall intimate in writing to this commission the status of information received or non-receipt of information within specified time period."

He states that the PIO has not furnished the information till date in spite of order of the commission.

**Respondent PIO** 

: PIO was represented by Shri Chera Ngoya, DNO PFMS (PR). He states that due to change of PIO on transfer, the information could not furnish in time. He has brought the information document today to hand over to the appellant.

#### Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing observes that the appellant has complied with the commission's order by submitting status report dated 23.12.2024. The appellant shall collect the information document from the PIO and submit a status report about adequacy of information received by him in the context of original RTI application in form A, to this commission and PIO within 10 days from the date of issue of this order i.e on or before 06.03.2025.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant within specified time. In case default this appeal case shall be disposed of without further hearing.
