## ORDER

- 1). This was an appeal under Section 19(3) of RTI Act, 2005 filed by Chau Sumanta Khen, Vill-Jenglai, PO- Piyong, PS-Namsai, District Namsai, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EAC, Chongkham Administrative Circle, Chongkham-Hq, District Namsai, Arunachal Pradesh Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 07/07/2023 regarding MGNREGA for the year of 2019- 2023.
- 2). The 5<sup>th</sup> hearing was held on 17<sup>th</sup> December 2024. Shri Kenge Loya , the PIO-cum-BDO, Chongkham Administrative Circle, Chongkham-Hq, District Namsai, Arunachal Pradesh Pradesh and the Appellant Chau Sumanta Khen attended the hearing through online mode of hearing (Video Conferencing).
- 3). The Commission had directed the PIO to give an AFFIDAVIT under intimation to the Commission, stating that the information as sought for by the Appellant at Sl.no. K, in his Form-A dated 07/07/2023 is not available in his office records. The AFFIDAVIT was to be furnished to the Appellant by 15<sup>th</sup> January 2025. The Appellant was directed to inform the Commission in writing receipt or non-receipt of the AFFIDAVIT by 20<sup>th</sup> January 2025, with a caution that if the Appellant failed to intimate, the case would be disposed of.
- 4). Since the Appellant has failed to intimate the Commission till date, the Commission decides to dispose of the case.
- 5). Therefore, the case is hereby disposed of.
