JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tageng Jorang on **28.12.2023** filed an RTI application in Form-'A' before the PIO-Cum-BDO, Kaying, Payum, Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **23.01.2024** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **26.03.2024** and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 155/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for once i.e on 14.05.2024. In this hearing of the appeal on 14th day of May,2024. Both the parties were absent during the hearing.

However, the Appellant has submitted a letter to the Commission on 13.05.2024 that he has received all the information sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
