The appellant file an RTI Application dated 15/02/2023 seeking Details regarding Expenditure & Implementation under SADA/ADA/RIDF/SIDF/RE/BE under WD Division Palin, Kra-Daddi District.

Being dissatisfied, the appellant filed First Appeal dated 24/05/2023. No any hearing has conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Dongru Tania on **24.05.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (RWD), Palin Division, Kra-Daddi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **06.07.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **07.08.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 749/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for nine times i.e on 21/12/2023, 02/02/2024, 01/05/2024, 19/06/2024, 12/08/2024, 09/09/2024, 11/11/2024, 10/02/2025 and 24/03/2025. In this hearing of the appeal on 24th day of March, 2025, both the parties PIO-cum-EE(RWD), Palin Division and appellant Shri Dongru Tania present in person. Appellant has submitted a written letter addressed to the Commission stating that he has received all the information as sought from the PIO and he is satisfied with the information. He also requested the Commission to close the appeal case No. 749/2023.

Request accepted and accordingly this appeal case No. APIC-749/2023 is disposed off and closed once for all.
