JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Riya Taram & Shri Takam Sakap on **17/05/2023** filed an RTI application under Form-'A' before the PIO-Cum- EE, RWD, Singchung Division District West Kameng, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **30/06/2023** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **02/08/2023**, and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 693/2023(Appeal)** and processed the same for its hearing and disposal.

Heard the Appellant;

Accordingly, matter came up for hearing before the Commission on **07/11/2024, 19/12/2024 & 06/03/2025**. In the first hearing the Appellants found absent without intimating the Commission the reason for their inability to attend the hearing. The PIO heard through online mode and stated that he is recently posted to this Division for which he could not provide the information(s).

In the final hearing on 06/03/2025, the Appellant Shri Riya Taram present in person and the PIO-Cum-EE, RWD, Singchung Di. W/Kameng Dist. Govt. Of AP, is present through online mode before the Commission.

The Appellant stated that the PIO has provided all the information(s) that he has sought in hios From-A completely.

Therefore, no further need to carry on this hearing so this Appeal may be disposed. Pursuant upon the procedural laws of the RTI Act, 2005, considering the request of the Appellant to dispose this instant appeal.

The Commission find that the appeal be disposed, and hereby orders:
