Information sought: The appellant filed an RTI application dated 06.08.2024 seeking following information: -

Particulars of information: C/o Road from Niya Namchang to Dobum village Banderdewa, P/Pare distt. A.P.

Detailed of information required:

- i) Furnish Xerox copies of tender paper published in 3 (three) local print media of the state.
- ii) Furnish Xerox copies of first and final bill.
- iii) Furnish the documents of those firms participated in the tender.
- iv) Furnish Xerox copies of the firm whom the work was awarded.
- v) Furnish Xerox copies of DPR and technical sanction of the said work.
- vi) Furnish Xerox copies of utilization certificate and completion certificate of the said work.
- vii) Provide the total payment status of the work in writing.

Periods: 2023-2024

The following were present.

Appellant : Present. He has received the information during the hearing and requested for time to examine and verify the document received from the PIO.

Respondent PIO : Absent. Represented by Shri Tayo Bagang, AE cum APIO. He has come up with the information which is available in PIO office and handed over to the appellant.

FAA : Absent. Represented by Shri Tana Tachu Tara, EE (P).

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records directs the appellant to examine the information furnished by the PIO within 2 weeks from the date of issue of this order. In case not satisfied with the information furnished by the PIO, the appellant shall file a written submission to the PIO clearly specifying the shortfall in the information furnished to him under intimation to this commission. The Commission directs the PIO to furnish any additional information within the ambit of the RTI application in form A to the appellant within 1 week on receipt of written submission from the appellant.

Hearing adjourned. Next date of hearing shall be fixed on receipt of compliance report from Appellant and PIO. In case no written submission received from the appellant within time stipulated, it will be presumed that the information to furnished to him is adequate and this appeal case shall be closed and disposed of without further hearing.
