Order of the fifth hearing: *"The commission has once again directed the appellant to collect the information from O/o the DFO, Pasighat, East Siang District, A.P. before next date of hearing. In case the appellant is not satisfied with the information he shall send a written submission explaining reasons for his dissatisfaction to the PIO with a copy marked to the commission. The said written submission should reach the commission at least 7 days before the next hearing, failing which appeal shall be disposed of assuming that the appellant has no intention of gaining access to the information."*

The following were present.

Appellant : Present. He states that the PIO has not furnished the information to him irrespective of his representative attended the PIO's office.

Respondent PIO : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing and perusal of the records, observes that the appellant has not complied with the Commission's Orders dated 27.10.2023 and 19.01.2024. The appellant shall serve a copy of this order to the PIO and obtain acknowledgement from the PIO / office within 10 days from the date of issue of this letter. The PIO shall furnish the information on the same day on receipt of this order. Both PIO and appellant shall submit compliance report of this order within 14 days from the date of issue of this order i.e 10.02.2025. In case no compliance report is received at commission from the appellant this appeal case shall be closed and disposed of without further hearing.
