JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Riya Taram, Shri Takam Sakap & Shri Tap Sajan on 17/8/2023 filed an RTI application in form 'A' before the PIO-cum EE (Power), Ziro Division Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application.

The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on 18/9/2023. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on 8/12/2023 and the Registry of the Commission (APIC) in receipt of the complaint registered it as APIC No-106/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up before the Commission, wherein the PIO present during the hearing but the Appellants Shri Riya Taram, Shri Takam Sakap & Shri |Tap Sajan were found absent for two consecutive times i.e 23/4/2024 & 21/5/2024, without intimating the reason to the Commission for their inability to attend the hearing. Moreover, the Commission through whatsapp intimated the Appellant Shri Riya Taram to attend today's hearing but he remained absent.

Heard the PIO

The PIO stated before the Commission that he has already intimated to the Appellants on dated 29/08/2024 for the fact, that the information sought by them in their Form 'A' application is too voluminous to furnish and not specific and spanning for 10-yrs time w.e.f 2014 to 2024, even the PIO requested the Appellant to resubmit the RTI application and mention specific informations sought for a certain period for easy furnishing of informations to RTI applicants as the present Appellant not being the only Applicant but till date no letter received from the Appellants.

Moreover, the copies of the informations sought by the Appellants were submitted before the Commission by the PIO. After hearing the PIO & going through the available documents, the Commission opines and observed that, the Appellants are no more interested for their appeal to let conduct further hearing.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.

While giving liberty to the Appellants to file a fresh RTI application to the Competent Authority as per the provisions of RTI Act, 2005, the Commission hereby dispose off the appeal.
