This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Mamu Sono, Sood Village, PO/PS-Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer (PIO), Govt. of A.P., O/o the District Panchayat Development Officer (DPDO), Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 14/11/2023 regarding the 14<sup>th</sup> Finance Commission in the year 2018-19 and 2019-20.
- 2). The 4<sup>th</sup> hearing was held on 3<sup>rd</sup> June' 2025 (Tuesday) at 1100 hrs. Ms.Nang Kalyani Namchoom, ADC, represented the District Panchayat Development Officer, Namsai District, Arunachal Pradesh was present through Video Conferencing (on hybrid mode of hearing).
- 3). The Appellant Shri Mamu Sono was not present in the court. However, the Appellant had submitted a representation letter vide No. Nil Dated 2<sup>nd</sup> June' 2025 addressed to the Commission informing that he had received all the information copy from the PIO-Cum-DPDO, Namsai and that he is fully satisfied with the information so furnished by the PIO and requested the Commission to dispose of the case.
- 4). Based on the written input given by the Appellant, the Commission observes it fit to dispose of the case.
