ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram for non-furnishing of below mentioned information by the PIO, o/o Executive Engineer, Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh, as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 30.10.2024.

A) Particulars of information: To furnish all the Relevant Information against Budget

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellant, Shri Riya Taram and two others had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the Chief Engineer, PWD, (C/Z), Itanagar, Govt. of Arunachal Pradesh the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dt. 04.12.2024. However, the appellants having failed yet again to obtain the information preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act. 2005 vide Memo of Appeal dated 17.02.2025.

Hearing & decision:

This appeal is listed today on 6th June, 2025 wherein the appellants are absent without any information but the PIO, Er. Shri Modak Riba, EE (PWD) Sangram Division is present in person with the requested documents/information.

This Commission notices that the PIO has brought in the documents as per the RTI application of the appellants except the deposit slip/voucher/treasury Challan etc. (Sl.No.22 of the RTI application). On query, the PIO submitted that due to absence of the Accountant (the dealing hand) who is on E/leave, the details could not be collated and therefore, need some time to furnish the documents.

This Commission considered the request of the PIO and allows him 2(two) weeks time to furnish the said left out documents. The appellants are also directed to collect the documents so furnished from this Commission and intimate their satisfaction or otherwise within one week thereafter failing which this appeal shall stand closed without further notice.
