ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Ngwazosa Yobin for non-furnishing of below mentioned information by the PIO o/o the Additional Deputy Commissioner, PO/PS : Miao, District Changlang, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 01.07.2024 :-

- (i) Furnish copies of total funds allocated for land compensation for construction of defense ALG (Advance Landing Ground) of Vijayanagr, with names of the land owners / beneficiaries.
- (ii) Furnish copies of total allocation of land compensation for the army / defense land of Vijayanagar.
- (iii) Sketch map of the existing defense land of Vijayanagar and its cadastral map.
- (iv) Details of land donors of the defense land of Vijayanagar,
- (v) All Government Notification published till date for land accusation and public hearing
- (vi) Details of payment made till date if any.

Records reveal that the Appellant herein had requested for the above information from the o/o the Additional Deputy Commissioner Mio but he could not get the information he, therefore, approached the First Appellate Authority, the D.C Changlang District, vide his Memo of appeal dated 06/08/24 but he failed to get any response from the o/o the First Appellate Authority which prompted him to approach this Commission under section-19 (3) of the RTI Act by filing his second appeal Memo dated 21/11/24.

This appeal was accordingly, listed for hearing on 05/02/25 and summons were issued to the parties.

In the meantime, however, the Appellant, Shri Ngwajosa Yobin, vide his letter dated 24/01/25 addressed to this Commission, which was received on 31/01/25, had intimated that he had received the information as sought for by him from the ADC, Mio on 02/12/24 via Gandhigram Post Office and requested for disposal of this appeal.

In the premises as above, the hearing of this appeal fixed on 05/02/25 stands canceled.
