JUDGEMENT

The 2nd hearing held on 11th February 2025, related to the APIC No. 1055/2023. The PIO-cum- Executive Engineer Public Health Engineering Department (PHED) Likabali Division, District Lower Siang, Govt. of Arunachal Pradesh, present in person during the hearing but the Appellant Shri Tagi Ruti found absent consecutively for two times during the hearing without intimating to the Commission the reason for his inability to attend the hearing.

Heard the PIO.

The PIO stated before the Commission that the information(s) as sought by the Appellant in his form 'A' application was sent to the Appellant via register post on dated 8/4/2024 same was also sent through WhatsApp messenger App on dated 6.4.2024., to the mobile telephone number of the Appellant.

The Commission observed;

The Appellant has not turned up for the hearing and therefore, confirmation of whether the information was received or not could not be ascertained. The PIO too is unsure whether the information was complete or incomplete.

Conclusion of the Commission;

Considering the Appellant's reluctant attitude and neglecting the directions of the court, the Commission believes that the Appellant must have received the documents, and that's why he has not deem it necessary to attend the hearing.

Judgment of the Commission;

In view of the above, facts and circumstances, and under the procedural of laws, the Commission proceed to dismiss this appeal ex-parte. And, accordingly, this appeal stands dismissed.
