ORDER

- 1). This was an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/PS Chimpu, Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- EE(WRD) Govt. of A.P., WRD Namsai Division, Namsai District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/05/2023 regarding the total list of project sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile - MSDP Scheme, Ministry of Minority Affairs Govt. of India during the financial year 2016-19.
- 2). The 9th hearing was held on 17th December, 2024. Shri C.J. Monnou, the PIO-cum- EE(WRD) Govt. of A.P., WRD Namsai Division, Namsai District, Arunachal Pradesh was represented by his legal counsel Adv. Bajangso Kri through Video Conferencing. The Appellant Shri Tamchi Gungte was present.
- 3). The Advocate representing the PIO had reiterated that the Appellant had been furnished with information at various occasion; 1st set of information was furnished during the 3rd hearing, thereafter, 2nd set of information were furnished through postal service and hard copies with proper authentication had been furnished during the 7th hearing held on 5th November, 2024.
- 4). As per the direction of the Commission in the 7th hearing held on 5th November, 2024 PIO waited for the Appellant for inspection in his office, but Appellant failed to appear. He also had appealed the Commission to dispose off the case, as all the information available in the office records had been furnished and an AFFIDAVIT with due justification had been provided for the information not available in the office.
- 5). The Appellant had informed the Commission that he had received the AFFIDAVIT and some information, which was incomplete. He had received some information related to GST. The Appellant also informed that due to health issue he could not visit the office of the PIO for inspection.

6). After hearing both the parties and taking note of issues, the Commission had directed the Appellant to have inspection of Document & Record under section 2(j) of the RTI Act, 2005. The PIO was also directed to keep records ready. The Commission had fixed **23rd December, 2024 (Monday), at 1130hrs** for the inspection and collection of information.

7). The Commission had cautioned both the parties that, if the inspection failed due to non-cooperation of the PIO, disciplinary action under section 20(2) of the RTI Act would be invoked against the PIO. In case the inspection failed due to non-appearance or non-cooperation of the Appellant the case may be closed and disposed of.

8). The Appellant was directed to intimate to the Commission before 24th December, 2024 the result of the inspection, failing which the case would be closed and disposed of without any further notice.

8). Since the Appellant has not intimated till date, the Commission decides to dispose of the case in view of larger public interest.

9). **Therefore, the case is hereby disposed of.**
