An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-434 /2024.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Karsang Tadu for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer, (PHE) Tali Division, Dist.: Kra Daadi Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 07-02-2024:

(A) <u>Particular of information</u>: Furnnish details of work, expenditure and implementation of scheme sanction under SADA (Special Area Development Authority) Pip Sorang Circle from 2019 to 2023.

(B) Details of information required:

- 1. Details with copy of allocation fund under the PHE Department and sanction order issued by Govt. of Arunachal Pradesh during the year 2019-2023.
- 2. Details of expenditure statement of SADA under Pip Sorang sub division, department of PHE during the year 2019-23.
- 3. Details of photograph with GPS or Geo-Tagging monitoring system during the year 2019-23.
- 4. Detail of vendor or firm name and details of payment made for each works to firm specially for each work during the year 2019-23.
- 5. Details of NIT and tender participation list copy with sanction order and Estimate, advertisement copy during the year 2019-23.
- 6. Details of payment procurement and materials provided to village wise work during year 2019-23.
- 7. Details of fund receive from department of Planning and investment, Govt. of A.P. during the year 2019-23.
- 8. Details of soft copy & hard copy during the year 2019-223.
- 9. Details of copy of monitoring & inspection team site visit report during the year 2019-23.

- 10. Details of the Graphic photo of starting work to completion work under subdivision, Pip Sorang, block during the year 2019-23.
- 11. Details of record entry book and MB No. during 2019-23.
- 12. Details of payment made to contractor with amount payment and cheque receive till date.

Records reveal that the Appellant failed to obtain the afore-mentioned information from the PIO o/o the Executive Engineer, (PHE) Tali Division, Dist.: Kra Daadi which prompted him to file 1st appeal before the 1st Appellate Authority, the Superintending Engineer, PHE & WS Circle Yachuli, Camp Naharlagun vide his Memo of Appeal dt. 14.03.2024.

The 1st Appellate Authority, in response to the said appeal, had vide letter dt.26.03.2024, without hearing the appeal in accordance with due process of law, forwarded the RTI application of the appellant to the POI, o/o the E.E, PHE & WS, Tali Division with an advice to furnish the information to the appellant. The records, however, further reveal that the PIO failed to provide the sought for information to the appellant despite the aforesaid order of the 1st Appellate Authority. Hence, this appeal before this Commission under section 19(3) of the RTI Act, 2005 vide Appeal Memo dt.27.03.2024.

This Appeal is, accordingly, listed today on 07.03.2025 for hearing wherein the appellant, Shri Karsang Tadu and the APIO o/o the Executive Engineer, (PHE & WS) Tali Division are present in person.

Heard the parties.

The Appellant, while reiterating his request for the sought for information, prayed for a direction to the PIO to furnish the information. The APIO, on the other had, submitted that he is not sure of the implementation of any scheme/project under the SADA by the Tali sub-division prior to bifurcation from the Palin Division in the year 2021-22. He further submitted that he will check and discuss with his Ex. Egr., the PIO and furnish the response accordingly.

This Commission, upon hearing the parties, directed the APIO, in the interim, to confirm the position and intimate the same to the Appellant and the Commission within 2(two) weeks from the date of receipt of this order so as to enable this Commission to issue an appropriate order.
