Information sought :

The appellant file a RTI Application dated 27/08/2023 seeking Details regarding Er. Kame Bengia, Executive Engineer (UD & Housing) from travelling abroad.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 28/09/2023. No any hearing has conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Podo Jamoh absent.
Respondent : PIO-cum-Executive Engineer (UD & Housing) present through VC.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Podo Jamoh **27.08.2023** filed an RTI application under Form- 'A' before the PIO-cum-Executive Engineer (UD & Housing), Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **28.09.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17.11.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1060/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 29/01/2025 and 17/03/2025. In this hearing of the appeal on 17th day of March, 2025, the PIO-cum-Executive Engineer (UD & Housing)) present in person but the appellant Shri Podo Jamoh found absent without any intimation to the Commission.

On the 1st hearing dated **29/01/2025** the appellant was directed to appear in person and convince the Court why third party information to be provided to him. Today he is again absent. The Commission deems that the appellant is no more interested to pursue the appeal case.

Therefore, the Commission deems fit to dispose off the case on the basis of statement made today by the PIO and failing of the appellant to convince the court that third party information is of larger public interest.

Accordingly, the appeal case No. APIC-1061/2023 is disposed off and closed once for all.
