JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Tamchi Gungte, on **23/03/2023** filed an RTI application in form 'A' before the PIO-cum-District Animal Husbandry & Vety. Officer (DAH & VO), Aalo, West Siang District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **02/06/2023**. Appellant again having not received the required information from the FAA, filed the Appeal before the Arunachal Pradesh Information Commission on **14/07/2023** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as **APIC- No. 635/2023 (Appeal)** and processed the same for its hearing and disposal.
