JUDGEMENT

Tap Sajan on 17/08/2023 filed an RTI application under Form-'A' before the PIO-Cum- EE, Department of Power, Basar Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
