<u>ORDER</u>

The 1st hearing held on <u>12th June, 2025'</u> related to the <u>APIC No-214/2025</u>. The Appellant Shri Mamu Sono is present in person during the hearing. The PIO-cum-EE, PWD, Kalaktang Division, West Kameng District Govt. of Arunachal Pradesh is also present in person during the hearing before the Commission.

Heard the APPELLANT;

The Appellant stated before the Commission that he has not received any information(s) from the office of the PIO till date.

Heard the PIO;

The PIO stated before the Commission that he has received 11 (eleven) Nos. of Form-A application from the Appellant on 25.10.2024 out of which the instant appeal is one and, on receipt of the same the PIO wrote a letter to the Appellant to minimize the Nos. of applications for which the furnishing of information(s) in stipulated time will be easier under RTI Act, 2005. But the Appellant did not respond and made an appeal before the First Appellate Authority (FAA). On 08.01.2025 FAA had ordered the PIO to provide the information(s) within 20 days to the Appellant.

In compliance with the order of the FAA the PIO again wrote a letter on 20.01.2025 to the Appellant to collect the information(s) from the office of the PIO, but the Appellant has not turned-up to collect the information(s), till date.

The Appellant requested the Commission to let the PIO post the information(s) through Postal, for which the PIO agreed very humbly.

After hearing both the parties the Commission hereby orders;

- The PIO to provide complete information(s) to the Appellant on or before the next date of hearing, failing which necessary action will be initiated as provided under RTI Act, 2005 against the PIO.
- Copy of this order need not be given to the parties as they are present in person during the hearing.

The next date of hearing be fixed on 23rd September, 2025' at 2:30 PM (Evening).
