Summon Notice.

The 3rd hearing held on 30th January 2025, related to the APIC No-223/2024. The Appellant Shri Dongu Josh found absent without intimating to the Commission the reason for his inability to attend the hearing consecutively 2(two) times, which prompt the Commission to believe that the Appellant is not serious on his appeal. The representative of the PIO Shri Tai Doru, A.E (PHE) Tali Sub-Division District Kraa-Daadi Govt. of Arunachal Pradesh, present during the hearing.

Heard the APIO.

The APIO stated before the Commission that he has written a letter to the Appellant on 24/7/2024 stating that his application is voluminous, ambiguous and un-specific spanning for 3(three) years making the information(s) sought voluminous and so to ease the burden of the PIO to provide the information(s), to abridge the particulars of information(s) and to be very specific rather than ambiguous allowing the office of the PIO running the office for giving other services to public also.

That regardless of the letter sent to the Appellant, the Appellant has not bothered to reply back and has not communicated back to the PIO till date. The statements of the Appellant are to be recorded for deciding the appeal but due to the absence of the Appellant, the hearing is adjourned today to be fixed on another day.

After hearing the representative of PIO the Commission ordered;

- (i) To **summon** the Appellant to appear in person or through online mode before the Commission in the next date of hearing. Failing which his appeal shall be decided ex-parte.
- (ii) Next date of hearing be intimated to the Appellant

The next date of hearing be fixed on 3rd April 2025 at 10:30 AM (Morning)
