SUMMON

WHEREAS, in connection with the **APIC-No. 185/2024**, your personal appearance is required before the Commission on **8th April, 2025 at 01:30 PM**. The **3rd** hearing held on **4th February, 2025** related to the **APIC No-185/2024**. The Appellant Shri Lokam Namdu and PIO-cum-District Horticulture Officer (DHO) Koloriang, both are found absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties, also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act, 2005, which is a statutory duty binding upon the PIO.

The Commission seriously viewed the absence of both parties and ordered;

- (i) To **summon** the Appellant to be present in person or through online mode before the Commission in the next date of hearing. **Failing which this appeal shall be decided Ex-parte.**
- (ii) To **summon** the PIO to provide all the information(s) to the Appellant on or before the next date of hearing as sought in his form 'A' application and to be present in the next date of hearing, **failing which action under section 20(2) shall be initiated against the PIO as per the provisions of RTI Act,2005.**

The Commission ordered;

The next date of hearing be fixed on 8th April'2025 at 1:30 at PM (A/Noon)
