HEARING NOTICE

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Mamu Sono, & Shri Tania Dongru, Sood Village, PO/PS-Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer (PIO), Govt. of A.P., O/o the Superintendent Engineer-cum-Coordination & Training, PWD (W/Z), Itanagar, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/11/2023 regarding the appointment of Jr. Engineer (JE) Civil, since 2015 to 2019.

2). The appeal case was heard on 03/10/2024 and remanded back to FAA for conducting proper hearing according to the guideline laid down at para-38 of OM.No. AR-111/2008 Dated 21st August, 2008. On perusal of files & folders, there is no record of hearing conducted by the FAA as directed.

3). **Whereas**, Shri Dani Gambo, HSIC decides to recuse himself from the case due to conflict of interest, as he had served as Chief Engineer in the same department.

2). **Now**, the HSCIC, decides to take up the case to hear and dispose of the said appeal under the provisions of the Right to Information Act, 2005. The hearing for the said appeal is fixed on **15th July, 2025(Tuesday) at 1100hrs before the Hon'ble Court of Major General Jarken Gamlin, AVSM, SM, VSM (Retd.), the State Chief Information Commissioner, Arunachal Pradesh Information Commission, Itanagar.**

3). **Therefore**, the Public Information Officer (PIO), Govt. of A.P., O/o the Superintendent Engineer-cum-Coordination & Training, PWD (W/Z), Itanagar, Arunachal Pradesh, and the Appellant are hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

4). Take notice that in case of default in appearance by the PIO on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and Section 20 (1) of the RTI Act, 2005 shall be invoked. In case the Appellant is found absent the case would be disposed of.
