The 8th hearing was held on 24th February, 2025 related to the APIC No-1012/2023(Appeal). PIO-cum-DFO, Pasighat is represented Shri T. Tapok, APIO but the appellant Shri Lenzing Pertin found absent without any intimation to the Commission.

Written reply of the Show Cause Notice received from the PIO-cum-DFO, Pasighat Forest Division.

Representative of the PIO has stated before the Commission today that the date for inspection of the document sought by the appellant was given by the PIO on 03/10/2024 and 25/01/2025. The letter was sent through dak runner but the appellant refused to accept and was sent again through postal address. The appellant never come to the office even though his residence is just 200 to 300 metres away from office of the DFO, Pasighat.

A letter received by the Commission from the PIO requesting to fix the date by commission to inspect the documents by the appellant.

The Commission accepted the written reply given by the PIO and the date is fixed by the Commission on 11/4/2025 for inspection.

The appellant is directed to inspect the documents on the fix date as per Sec. 2 (J) (i) of the RTI Act and intimate within 15 (fifteen) days to the Commission. If no intimation is received from the appellant, the Commission will deemed that appellant is satisfied and the appeal case will be decided accordingly.

The Commission fixed next date of hearing on 28/04/2025 at 1030 hours.
