## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Riya Taram, Adv. Bengia Tahar & L.Namdu, Huto colony, Riang Store near Catholic Church, Jollang Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(Electrical), Govt. of A.P., Tawang Electrical Division, Tawang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 03/01/2025 regarding the relevant information against the utilization of fund under RE from 2016-2024.
- 2). The 1<sup>st</sup> hearing was held on 3<sup>rd</sup> June, 2025. The PIO-cum-EE(Electrical), Govt. of A.P., Tawang Electrical Division, Tawang District, Arunachal Pradesh vide letter No. TED/W-84/RTI-1/2025-26/409-13 Dated 20/05/2025 submitted that due to visit of Hon'ble Chief Minister of Arunachal Pradesh for a week tong programme he would not be able to attend the court hearing.
- 3). The Appellant submitted that he has not received any information from the PIO.
- 4). The Commission makes clear that the statutory duty and summon from the court should be given privilege over other normal duties or VVIP duties. Violation of provisions of RTI Act, 2005 is tantamount to violation of Constitut on of India and infringement of fundamental rights of citizen under Article 19(1)(a). Thereby, the Commission cautioned the PIO, not to repeat the same in near future. The Commission giving reasonable opportunity to the PIO decides to fix next date of hearing.
- 5). The next date of hearing is fixed on 8th July, 2025 (Tuesday) at 1100hrs.

6). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission will initiate penal action against the PIO under section 20(1) of the RTI Act-2005. In case Appellant is found absent the case shall be disposed of.
