**Particular of information:** c/o "the total list of project sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile-MsDP Scheme, Ministry of Minority Affairs Govt. of India" during the financial year 2018-19.

- i. Construction of 100 bedded Girls Hostel at Govt. Secondary School, Monigong in Mechuka Block of Shi Yomi District.
- ii. Construction of 50 bedded Girls Hostel at Govt. Secondary School, Tato in Mechuka Block of Shi Yomi District.
