ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV2 School, Chimpu, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- EE(PWD), Deptt. of PWD, Mariyang Division, PO/PS Mariyang, Upper Siang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A dated 09/10/2024 regarding Construction of Road from PWD Road to Pekimodi in Upper Siang District (22.11km) under North East Special Infrastructure Development Schemes(Road) during the financial year 2024-25.
- 2). The re-scheduled 1st hearing was held on 27th May, 2025. Shri Bom Borang, the PIO-cum- EE(PWD), Deptt. of PWD, Mariyang Division, PO/PS Mariyang, Upper Siang District, Arunachal Pradesh had brought the requisite information and furnished the same to the Appellant during the hearing and the Appellant after receiving the same had appealed the Commission to give time to go through the information.
- 3). The Appellant vide letter No. NIL dated 04/06/2025 informed the Commission that the PIO had furnished **incomplete and unsatisfactory information** for the Sl.no. 2, 7, 8, 9, 10, 11, 12, 14, & 15 of the Form-A dated 09/10/2024.
- 4). The Commission, decided to fix next date of hearing to ensure compliance by the PIO and also provide an opportunity to the PIO to respond to the Appellant.
- 5). The next date of hearing is fixed on 15th July, 2025 (Tuesday) at 1100hrs.

6). Therefore, Shri Bom Borang, the PIO-cum- EE(PWD), Deptt. of PWD, Mariyang Division, PO/PS Mariyang, Upper Siang District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail. Take notice that in default of your appearance on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
