The appellant filed an RTI application dated 10.06.2023 seeking information pertaining to the sanction Order vide NO.FOR.332/STATE AUTHORITY/2023/1295-1311 dated 10.06.2024.

- iv) Copies of Notifications issued for Pingang VFR, Longro VFR, and all other Reserved Forests under Kurung Kumey Forest Division with Minutes of Meeting and agreement, if any.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing and perusal of the records observes that the FAA – Chief Conservator of Forest, Western Circle, Banderdewa Govt. of Arunachal Pradesh has heard the first appeal on 27.08.2024 wherein the PIO was absent. Today also the PIO remained absent for second appeal hearing in this commission court. The PIO is directed to furnish the information as sought for in RTI application form-A within two weeks from the date of issue of this order i.e on or before 21.02.2025 free of cost. The PIO shall file a written statement to this commission after delivering the information to the applicant within three weeks from date of issue of this letter and he shall attend the next hearing in person. The appellant shall approach the PIO / his office for obtaining the information as per this order and submit a report to this commission court.

Hearing adjourned. Next date of hearing shall be fixed on receipt of compliance report from the PIO and appellant.
