ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Kimin Ingo, for non-furnishing of below mentioned information by the PIO, o/o the Registering Officer, APB & OCWWB, Aalo, West Siang Distt. Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 26.09.2024.

Details of information required:

1. As per Sanction Order dated 16th June, 2022, the HQ office, APB&OCWWB, Itanagar had sanctioned of Rs.15,0450.00 Rupees Fifteen Lakhs Four Hundred Fifty) only in respect to your good office for statutory benefits. Henceforth, furnish — the total expenditure details of the above mentioned sanctioned amount.
2. As per Sanction Order dated 30th August, 2023, the HQ office, APB&OCWWB, Itanagar had sanctioned of Rs.24.12 Lakhs (Rupees Twenty Four Lakhs Twelve Thousand) only in respect to your good office for statutory benefits. Henceforth, furnish the total expenditure details of the above mentioned sanctioned amount.
3. On 17.03.2023, your good office had acknowledged and received around 1230 Water Filter pcs and on 16.03.2023, your good office had acknowledged and received around 1236 pcs of water Filter and 3330 pcs of Tiffin carrier from HQ . APB&OCWWB, Itanagar for the distribution to the beneficiaries. Henceforth, furnish the name list and details of Beneficiaries with their ENROLMENT OR REGISTRATION NUMBER who have received the same.
4. Date month, year, venue (name of village), banner, group photos in coloring with beneficiaries expenditure of each "Awareness Camp" in separate sheet in the year 2022 and 2023.
5. All the documents within 30 days as per RTI Act, 2005 and reply in sequence as well as proper paging as per above mentioned points with proper CTC

This appeal was listed and heard on 28.05.2025 wherein the appellant was represented by Ms. Mama Bengia but the PIO was absent without any information.

This Commission, after hearing the representative of the appellant, who submitted that the appellant had received from the PIO the replies/information against his queries at Sl. No.1,2 and 3 of his RTI application but did not receive the replies against the query at Sl. No.4 i.e the date, month, year, venue (name of villages, banner, group photos in colour with beneficiaries and total expenditure of each "Awareness Camp" in separate sheet in the year 2022 and 2023), issued direction to the PIO to

furnish the left out information to the appellant within 2(two) weeks from 28.05.2025 i.e on or before 11.06.2025. The appellant was also directed to intimate to this Commission the receipt of the left out documents within 2 (two) days from the date of receipt of the documents for further consideration of this appeal.

The appellant has now informed this Commission vide his letter dt.12.06.2025 that the PIO did not comply with the order of this Commission and therefore, prayed for hearing the appeal again.

In the premises as above this appeal is again listed on 25th July, 2025

NOW THEREFORE, You are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on 25th July, 2025 (Friday) at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
