## **ORDER/SUMMONS**

This was a Complaint case under Section 18(1) of RTI Act, 2005 received from Shri Tania June & Shri Issac Ejing for denial of information by the PIO, o/o the Executive Engineer (PHE & WS), Yingkiong Division, Upper Siang District & sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 05.11.2024.

A)Particular of information: Improvement of Water Suplysustem in Katan Circle in Upper Siang District.

This case was listed 3(three) times on 21.03.2025, 11.04.2025 and 14.05.2025. The PIO did not apear in any of the dates. On 14<sup>th</sup> May, 2025, however, Er. Shri Tumba Ingo, A.E representing the PIO was present in person and submitted that due to acute shortage of staff in the o/o the PIO and the voluminous nature of information/documents requested by the complainants/ appellants, the PIO could not furnish the requested information. On the other hand, the complainant/appellant submitted that the sought for information is specific and for one scheme only which the PIO can arrange to furnish without any difficulty.

This Commission, upon perusal of the details of information/documents requested by the complainants/appellants did not find that voluminous and therefore, directed the PIO to provide the same within 30 days from 14.05.2025 or on or before 13.06.2025 i.e the next date of hearing.

In today's hearing also the PIO did not appear either in person or online without any intimation nor did he depute anyone.

The appellant, who is present in person today on 13.06.2025, expressed his disappointment over the response of the PIO and demanded for an penal action under the relevant provisions of the RTI Act.

The continued absence of the PIO in the hearing without any intimation has been viewed seriously by this Commission. Such non-response amounts to violation of the provisions of RTI Act and also blatant disrespect to this Commission. This Commission is, therefore, directs the PIO to appear in the next hearing with the left out documents and it is made clear that if he fails to appear again, this Commission shall be constrained to impose penalty as prescribed under section 20(1) of the RTI Act, 2005 and this order shall be treated as Show Cause Notice to him.

The appeal is listed again on 16<sup>th</sup> July, 2025. Given under my hand and seal of this Commission on this 13<sup>th</sup> June, 2025.

You are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on the 16<sup>th</sup> July, 2025 (Wednesday) at 10.30 am to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

**NOW THEREFORE**, take notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence.
