Summon Notice. The 3rd hearing was held on 9th June, 2025 related to the APIC No-358/2024(Appeal). PIO is represented by Er. K. Welly, APIO through VC. The appellant found absent however, he has intimated through telephonic to the Commission that due to health ground he is unable to attend the hearing.

A letter has been received from the Chief Engineer (RWD), Western Zone stating that 9 divisions of the RWD Executive Engineers have intimated regarding the information sought as per the Form ;A;. Out of 9 division Laaying Yangte RWD Division has provided information, rest of the Division Tawang, Mechuka, Itanagar, Basar, Pakke Kessang, Singchung, Aalo and Lumla have reported nil regarding the sought information. APIO has stated that the information provided by the Executive Engineer (RWD), Laaying Yangte Division will be provided to the appellant. APIO has also stated that the Sagalee Division has already attended in the hearing and submitted nil report.

As per the statement made by the APIO of the Chief Engineer (RWD), out of 19 RWD Division of the Western Zone RWD, 10 Divisions have already reported rest of the 9 Division Poma, Seppa, Daporijo, Ziro, Bameng, Jamin, Raga, Tali and Likabali have not intimated. No more notice to be sent to the 9 Divisions as they have already given nil report as they have no information as sought for.

On the last hearing dated 12/03/2025 PIO was directed to provide the information as per the Section 10 of the RTI Act. Notice was issued to the Proprietor why the information should not be provided. On the order dated 21/04/2025in the order it is reflected that notice was served to M/s Zee Engineering and Constructions but no such objection been received from the third party so far.

In response to order dated 21/4/2025 Proprietor of M/s Zee Engineering & Constructions stated that She was not given chance to reply for making submission before the Commission. She was given information very late regarding the order given by the Commission.

She stated that she did not receive a letter of summon to appear hearing on 21/4/2025. Moreover, the intimation of Firm is written as M/s Gee Engineering & Construction instead of Zee Engineering and Construction.

Today, the Learned Counsel appeared on behalf of the M/s Zee Engineering Construction. The Commission allows to make his submission on behalf of M/s Zee Engineering and Construction.

The learnt Counsel has made oral submission for rejection of the application sought as per the Form 'A' Application except information sought at Sl. No. 2 & 3. The Commission is not convinced by the oral submission made by the Counsel. The Commission gives one more chance to the third party M/s Zee Engineering & Constructions to make a submission with reference to recent ruling if available in the next date of hearing.

The appellant is directed to appear in person before the commission in the next date of hearing and make his submission if any.

The Chief Engineer (RWD), Western Zone is directed to give notice to all the Executive Engineer (RWD) of the 9 Division Poma, Seppa, Daporijo, Ziro, Bameng, Jamin, Raga, Tali and Likabali for providing information as sought in Form 'A' except 10 Division who have already been submitted nil report.

The Commission fixed next date of hearing on 20/08/2025 at 2 PM.
