### **ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Larmin Taipodia & Shri Lari Ruti for non-furnishing of below mentioned information by the PIO, o/o The District Land Revenue & Settlement Officer, Department of Land Management, Likabali, Lower Siang District, Govt. Arunachal Pradesh as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 06.10.2023.

**A) Particular of information:** LPC issued to 31 individuals at Siri area LPC map with member list.

**B) Details of information :**

1. Furnish the certified information regarding the 31 individuals at Siri Area with Form submitted for issue of LPC.
2. Furnish the photo copy of all the LPCs certificate with map of mentioned 31 individuals.
3. Furnish the challan copies of 31 Individuals.
4. Furnish the copy of letter submitted for Geo tag and survey of said land.
5. Furnish the order copy for Geo Tag and Survey of 31 individuals for Siri area.

**Brief facts emerging from the appeal :**

Records emerging from the appeal disclose that the Appellant, Shri Larmin Taipodia & Shri Lari Ruti had requested the PIO for the aforementioned information/documents but failed to obtain the same which prompted them to appeal before the Deputy Commissioner, Likabali, Lower Siang District, Govt. of A.P, the First Appellate Authority (FAA) under Section 19 (1) of the RTI Act, 2005 vide Memo of Appeal Dated 15.01.2025. However, the appellants having failed yet again to obtain the information, preferred 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dated 03.03.2025.

**Hearing & decision:**

This appeal is, accordingly, is listed today on 6<sup>th</sup> June, 2025 for hearing wherein one of the appellants, namely Shri Larmin Taipodia and the PIO, Shri Chogge Nyodu, DLRSO were present through VC.

Heard the parties.

The PIO submitted that the requested documents/information had already been furnished to the appellants on 25.03.2025, while the appellant, submitted that he did not receive the documents. The PIO assured to furnish all the requested documents to the appellant within one week from today.

This Commission, upon hearing the parties, hereby directs the PIO to furnish the documents and the appellant is directed to collect the documents from the office of the PIO on coming Thursday i.e 12.06.2025 as suggested by the PIO and intimate this Commission of the receipt of the same within one week thereafter for further consideration of the appeal.
